The Government of Uganda with support from the World Bank is implementing the Uganda Intergovernmental Fiscal Transfer (UGIFT) Program, and has allocated funds to be utilised for the acquisition of individual consultancy services to develop a framework for national government coordination oversight and technical support to Local Government irrigation service delivery for Ministry of Agriculture, Animal Industry and Fisheries.
2. The Ministry of Finance, Planning and Economic Development – Resource Enhancement and Accountability Programme (REAP) hereby invites sealed proposals from eligible individual consultants to provide the aforementioned services.
