- 1. The Government of Uganda with support from the World Bank is implementing the Uganda Intergovernmental Fiscal Transfer (UGIFT) Programme, and has allocated funds to be utilised for the acquisition of computer tablets to support the Programme.
- 2. The Ministry of Finance, Planning and Economic Development the Resource Enhancement and Accountability Programme (REAP) hereby invites sealed bids from eligible bidders to provide the aforementioned supplies.
- 3. Bidding will be conducted in accordance with the Open Domestic Bidding method contained in the Public Procurement and Disposal of Public Assets Act, 2003, and is open to all bidders.
- 4. Interested eligible bidders may obtain further information and inspect the bidding documents at the address given below at 8(a) from 0800 1700hrs (Kampala Time) on working days.
- 5. The Bidding documents in English may be acquired on submission of a written application to the address below at 8(a), and upon payment of a non-refundable fee of UGX 100,000 (Uganda Shillings One Hundred Thousand only). Interested Bidders may make payment to the URA collection account at commercial banks, quoting the Procurement Reference Number above. The **bank advice and the application** shall be presented for issue of the Bidding Document, to the address below at 8(a).

6. Bids must be delivered to the address below at 8 (b), at or before **1100hrs** (Kampala Time) on **29<sup>th</sup> December 2022.** All bids must be accompanied by a bid security

Late bids shall be rejected.
