- 1. The Ministry of Finance, Planning and Economic Development through the Resource Enhancement and Accountability Programme (REAP), has allocated funds for the acquisition of computers and a printer.
- 2. The Entity hereby invites sealed bids from eligible bidders for provision of the above supplies.
- 3. Bidding will be conducted in accordance with the Open Domestic Bidding method contained in the Public Procurement and Disposal of Public Assets Act, 2003, and is open to all bidders.
- 4. Interested eligible bidders may obtain further information and inspect the bidding document by sending an enquiry to the **email** address below at 8 from 0800 1700hrs (Kampala Time) on working days.
- 5. The Bidding document in English may be acquired by interested bidders on the submission of a written application to the address below at 8, and upon payment of a non-refundable fee of UGX 100,000 (Uganda Shillings One Hundred Thousand only). Interested bidders may make the payment to the URA collection account at commercial banks, quoting the Procurement Reference Number above as the narrative. The **bank advice and the application** for the Bidding document shall be presented to the address below at 8.
- 6. Bids must be delivered to the address below at 8, at or before **1400hrs** (Kampala Time) on **4 November 2021**.

All bids must be accompanied by a bid securing declaration. Late bids shall be rejected.

Bids will be opened in the presence of the bidders' representatives who choose to attend the virtual ZOOM meeting on 4 November 2021 at 1430hrs.
