- 1. The Government of Uganda with support from the World Bank is implementing the Uganda Intergovernmental Fiscal Transfer (UgIFT) Programme, and has allocated funds to be utilised for the acquisition of ICT equipment to support the Program.
- 2. The Ministry of Finance, Planning and Economic Development the Resource Enhancement and Accountability Programme (REAP) hereby invites sealed bids from eligible bidders to provide the aforementioned supplies.
- 3. Bidding will be conducted in accordance with the Open Domestic Bidding method contained in the Public Procurement and Disposal of Public Assets Act, 2003, and is open to all bidders.
- 4. Interested eligible bidders may obtain further information and inspect the bidding documents at the address given below at 8(a) from 0800 1700hrs (Kampala Time) on working days.
- 5. The Bidding documents in English may be acquired on submission of a written application to the address below at 8(a), and upon payment of a non-refundable fee of UGX 100,000 (Uganda Shillings One Hundred Thousand only). Interested Bidders may make payment to the URA collection account at commercial banks, quoting the Procurement Reference Number above. The **bank advice and the application** shall be presented for issue of the Bidding Document, to the address below at 8(a).
- 6. Bids must be delivered to the address below at 8 (b), at or before **1100hrs** (Kampala Time) on **26<sup>th</sup> October 2023.** All bids must be accompanied by a bid security of UGX4,000,000 (Uganda Shillings Four Million). Late bids shall be rejected.

Bids will be opened in the presence of the bidders' representatives who choose to attend on **26<sup>th</sup> October 2023** at **1130hrs** in the board room at the address at 8 (b) below.
