- 3. Bidding will be conducted in accordance with the Open Domestic bidding method contained in the Public Procurement and Disposal of Public Assets Act, 2003, and is open to all bidders.

Late Proposals shall be rejected. Proposals shall be opened in a virtual ZOOM meeting in the presence of the consultants and / or their representatives who choose to attend on Friday **01 October 2021** at **1530hrs** (**Local Time**).
