- 3. Bidding will be conducted in accordance with the Open Domestic Bidding procurement method and is open to eligible consultancy firms.

The **bank advice and the application** shall be presented for issue of the Request for Proposal Document, to the address below at 8(a).

- 6. Proposals must be delivered to the address below at 8(b), at or before **1100hrs** (Kampala Time) on **3rd November 2022**. Late proposals shall be rejected. Proposals will be opened in the presence of the consultants' representatives who choose to attend the meeting on **3rd November 2022**.
