1. The Government of Uganda has allocated funds to be utilised for the acquisition of consultancy services to develop project preparation and appraisal manuals for agro-industrialization and natural resources, environment, climate change, land and water management programmes.
2. The Ministry of Finance, Planning and Economic Development – Resource Enhancement and Accountability Programme (REAP) hereby invites sealed proposals from eligible consultancy firms to provide the aforementioned services.
3. Bidding will be conducted in accordance with the Open Domestic Bidding procurement method and is open to eligible consultancy firms.

5. The Request for proposals document may be acquired on submission of a written application to the address below at 8(a), and upon payment of a non-refundable fee of UGX 100,000

6. Proposals must be delivered to the address below at 8(b), at or before **1100hrs** (Kampala Time) on **3rd November 2022**. Late proposals shall be rejected. Proposals will be opened in the presence of the consultants' representatives who choose to attend the meeting on **3rd November 2022**.
