Adroit Consult	<ul style="list-style-type: none"> • Did not provide a copy of Memorandum & Articles of Association or equivalent as required. • Did not provide a copy of audited books of Accounts and financial statements for the last two years 2018 and 2019 as required. • The firm did not meet the required specified experience – It does not have an internationally recognized track record in providing services in the areas of Monitoring and Evaluation, Public Financial Management, Economic Policy Management, Good Governance, Public Sector Management, Extractives Revenues, Taxation Management and Tax Policy, Revenue Management and Fiscal Regimes. The international track record provided is not in any of the areas required and specified above. • The team leader did not meet requirement of 5 years' experience in undertaking research and providing technical assistance in extractives sector governance. His experience is hardly one year in the required field (2014-2015). • The team leader is short of expertise in extractives revenues, taxation management and tax policy. • The team leader did not have proven experience in working to support the development of sound transparency and accountability mechanisms for extractives revenue generation, revenue management and accountability. His experience is generic and not specific to the required areas.


Management, Good Governance, Public Sector Management, Extractives Revenues, Taxation Management and Tax Policy, Revenue Management and Fiscal Regimes.

The firm's experience is mainly in events management, marketing and branding which is not among the areas of experience required.

- **The team leader** did not meet the requirement of 5 years' experience in undertaking research and providing technical assistance in extractives sector governance. **His experience is mainly in the area of development planning and communication which is not among the areas of experience required.**
- **The team leader** did not have the knowledge and expertise in extractives revenues, taxation management and tax policy as required.
- **The team leader** did not have strong knowledge and understanding of Uganda's extractive sector policy and legal frameworks. He is mainly knowledgeable in development planning and communication.
- **The team leader** did not have proven experience in working to support the development of sound transparency and accountability mechanisms for extractives revenue generation, revenue management and accountability. **His experience is generic and not specific to the required areas.**
- **The firm did not provide a reference letter** from government confirming the successful implementation of similar consultancy services and certificate of completion.
- The firm submitted a copy of Audited books of accounts for the last 2 years 2018 and 2019 as required. However, the books of accounts submitted were not satisfactory given that the firm was incorporated hardly a year back on 12th June 2019 which period does not cover

		the two audited years requested for.

He possesses a Master's degree in Accounting which is not the required qualification.

PricewaterhouseCoopers (PWC) Limited	<ul style="list-style-type: none"> • The team leader did not possess the relevant Master's degree in either Development Studies, Economics, Economic Policy Management, Law or Public Policy with some elements of international development and extractives. He possesses a Master of Science - Forensic Accounting which is not the required qualification. • The firm did not provide a copy of audited books of Accounts and financial statements for the last two years 2018 and 2019 as required. <p>Much as it is indicated in the table of contents that the books of accounts provided are for 2018 and 2019, the books of accounts submitted are for years 2017 and 2018.</p>
